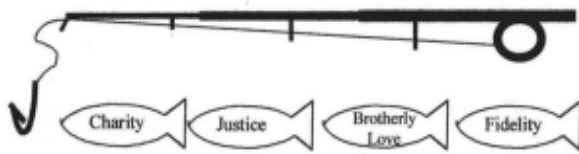

I'm pleased to report that the Lodge is in excellent shape. Since the Lodge year ends on March 31<sup>st</sup>, I forecast that we will be in even better shape, when the reins of leadership are passed to Sally. **CHEA MEMBERSATION  
RETENTION / LAPSATION CHAIRMAN**

Tom Ryder - PDDGER

Taken from an article by Dr Steve Goosen published in the Journal of General Hospital Rochester.

As Membership Retention/Lapsation Chairman I want all lodges to retain all of their members! Following the procedure in this article could possibly help retain some members. Please read it carefully.

**HEART ATTACK**

Some advice on what to do when you have a heart attack and what to do until you get help.

Let's say it's 6:15 pm and you're driving home (alone of course) after an usually hard day on the job. You're really tired and frustrated.

- You are really stressed out and upset -

Suddenly you start experiencing severe pain in your chest that starts to radiate out into your arm and up into your jaw.

You are only five miles from the hospital near your home.

Unfortunately you don't know if you will be able to make it that far.

**WHAT TO DO ???**

You have been trained in CPR, but the guy who taught you the course did not tell you how to perform CPR on yourself! !

**HOW TO SURVIVE A HEART ATTACK WHEN ALONE?**

Since many people are alone when they suffer a heart attack, and without help, the person whose heart is not beating properly and who begins to faint, has only about 10 seconds left before losing consciousness.

**WHAT TO DO??? ANSWER:**

Do not panic, but start coughing repeatedly and very vigorously.

A deep breath should be taken before each cough. The cough must be deep and prolonged, as when producing sputum from inside the chest.

A breath and cough must be repeated about every two seconds without let up until help arrives, or until the heart is felt to be beating normally again.

**WHY ???**

Deep breaths get oxygen into the lungs.

Coughing squeezes the heart and keeps the blood circulating.

The squeezing pressure on the heart also helps it regain normal rhythm. In this way heart attack victims can get to a hospital.

Tell as many people as possible about this, it could save their lives!

Don't ever think that you are not prone to heart attack.

Nowadays heart attack is found among people of all age groups.

Be a good friend and a good Elk. Give this article to as many friends as possible!

### NEW FACILITIES CONSTRUCTION UPDATE

The lodge approved on the floor a motion to seek an additional loan of up to \$750,000 to start our construction of the new lodge building. This doesn't mean we are getting a loan; we will need further approval from the lodge members before we sign the bottom line for a new loan. What the new facilities committee is doing now is analyzing all of our different methods of procuring a loan. Along with that

we are going over exactly what will be required of our operations to service the new loan along with our current bond issue.

Len Cardoni is continuing to work with the city planners on the outside appearance of the new building. He had made several trips to the planning department and every trip requires a few more cosmetic changes. Hopefully by the time you are reading this, the new artist concept drawings will be approved and on display at the lodge.

The surveyors are developing the drawings required before we start grading. Property lines have to be established and cut and fill calculations have to be made. This may seem like a minor undertaking but keep in mind, there is a difference of almost 20 feet in elevation from one corner of our property to another. For a building with a cement slab that is as long as our proposed new building it will take quite a bit of engineering to get the ground levels correct. When you factor in the changing curb lines and the proposed separation walls from our neighbors, there is a lot of work involved.

No construction update would not be complete without an appeal for more building funds. Our bond sales have slacked off but through the efforts of Tommy Claunch, David Pearson, Bill Sternberg and many others we are continuing to build up the new facilities fund. These efforts are greatly appreciated. As I have pointed out before, our building costs are going up about \$10,000 a month due to inflation. We still need more help so please, if you haven't purchased a bond yet, please do so. If you have purchased a bond, think about purchasing another. The more money we raise through fund raising and our bonds, the less we have to borrow from an outside source.

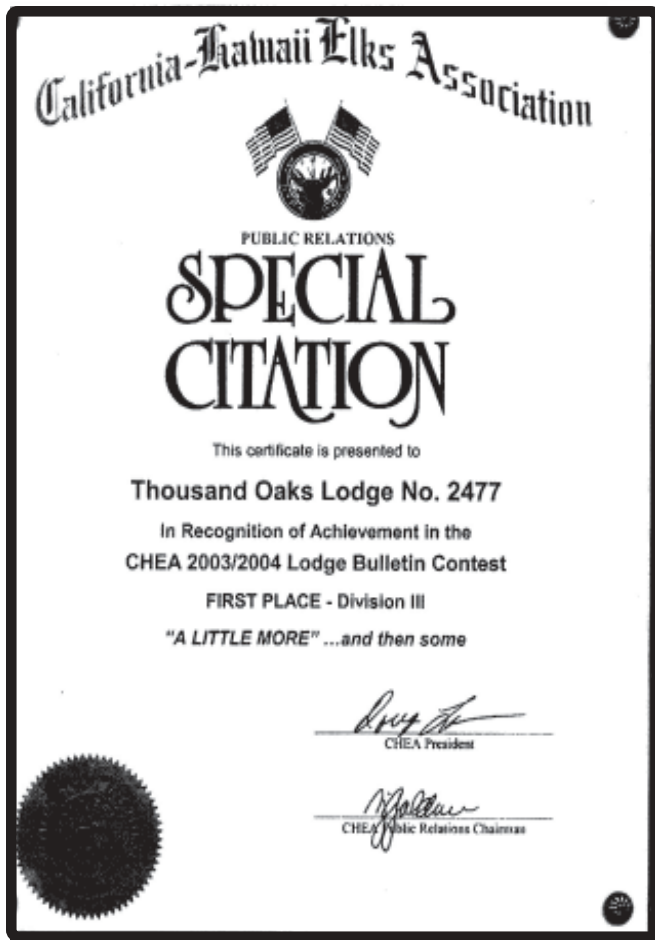
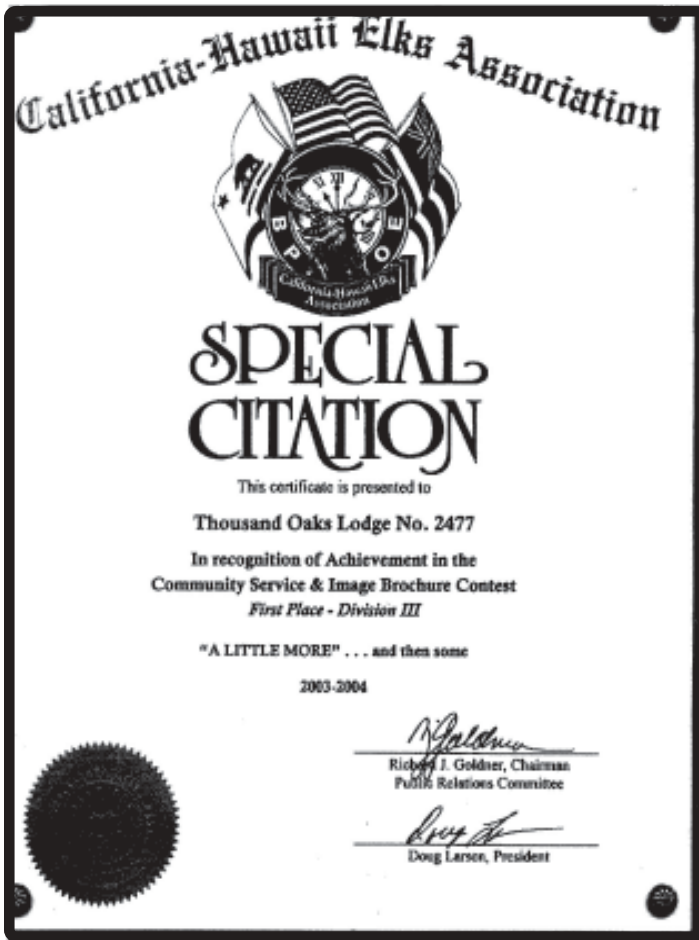
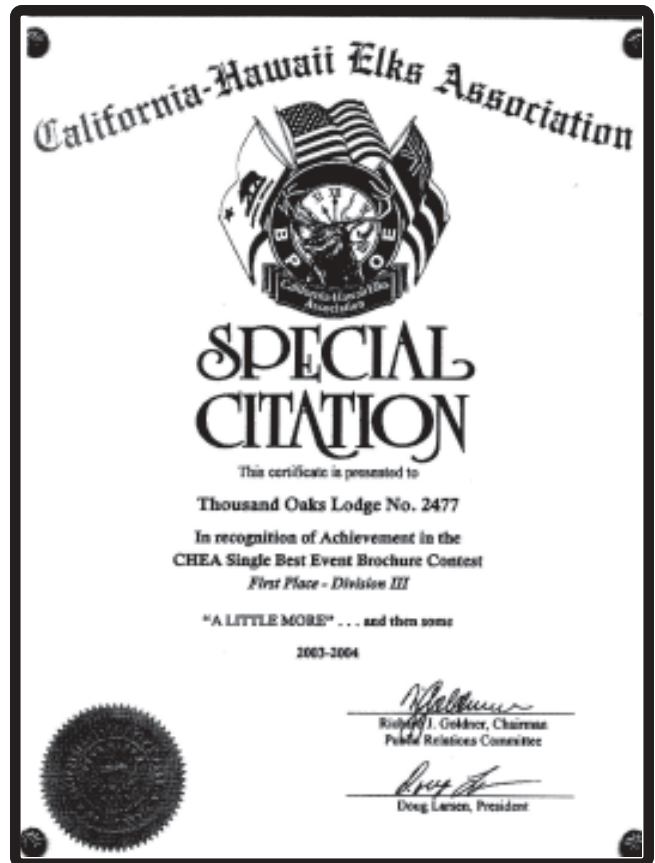
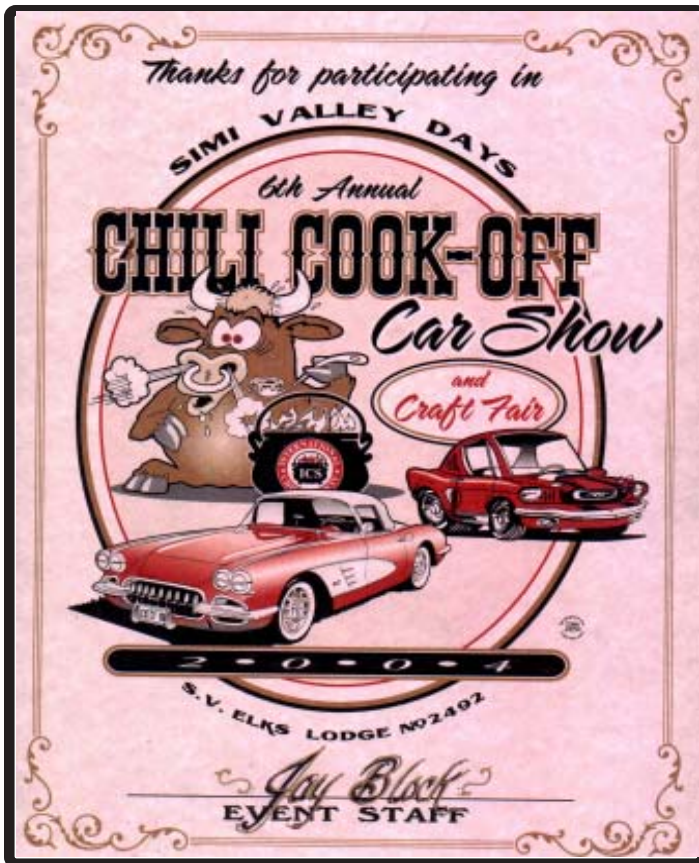
*Hi, my name is Mike Ray.*

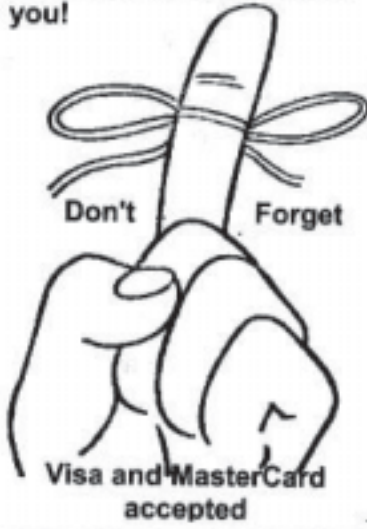

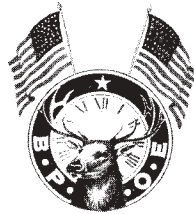


